**SUBJECT:** Hatch Act Compliance

I expect all USDA employees to adhere to the highest ethical standards not only in their official duties, but also in any political activities they undertake. Now is a good time for us to review some of the prohibitions concerning political activities that apply to the great majority of Federal employees. I do not discuss here the stricter rules that apply to career Senior Executive Service employees; Board of Contract Appeals members and Administrative Law Judges; or the generally more permissive rules that apply to Presidential appointees confirmed by the Senate. Nonetheless, this reminder should be applicable and helpful to the majority of USDA employees. I encourage you to seek guidance from your Agency Ethics Officials or Departmental Administration's (DA) Office of Ethics should you have any questions about how the rules apply to you.

Most USDA employees are subject to the Hatch Act Reform Amendments of 1993 (Amendments). The Amendments broadly permit covered employees to take an active part in political management or in political campaigns *on their own personal time and away from the worksite*. Some of the partisan political activities in which covered employees may participate include: making speeches, distributing literature, participating in partisan "get-out-the-vote" drives, working at the polls, managing campaign organizations, serving as a party officer, serving as a delegate at conventions, and signing nominating petitions.

At the same time, covered employees are subject to a number of general restrictions. As a Federal employee, you may not:

1. Run for partisan political office;
2. Use your official title while participating in any political activity;
3. Solicit, coerce, or discourage the political activity of any person who
  - a. has any application pending before the Department or
  - b. is a subject or participant in any ongoing audit, investigation, or enforcement action being carried out by the Department;
4. Use your official authority or influence to interfere with or affect the result of an election;

5. Solicit, accept, or receive volunteer services from a subordinate for any political purpose;
6. Engage in any political activity while: On duty; wearing a uniform or official insignia identifying the office or position of the employee; or in any room or building used by Government employees in the discharge of their official duties. Political activity includes work for campaigns or a political party, writing political speeches, endorsing candidates, holding political meetings, and combined political and official Government travel;
7. Engage in political activity while using any Government-owned or leased vehicle or while using a private vehicle in the discharge of official duties. Political activity includes displaying a political bumper sticker or decal and also includes driving to political events; or
8. Personally solicit, accept, or receive a political contribution from ANY person, unless that person is a member of the same labor organization and not a subordinate employee. The solicitation is for a contribution to a multi-candidate political action committee (PAC) of the labor organization.

Political fundraisers are a frequent source of problems. You may not:

1. Solicit political contributions in a speech given at a fundraiser endorsing a candidate or party;
2. Use your official title in connection with fundraising activities;
3. Host, sponsor, or invite others to a fundraiser; or
4. Allow your name to be used on an invitation to a fundraiser as a sponsor or point of contact.

Finally, USDA employees have recently sent several e-mails on political subjects, while they were on duty and from Government computers. The general rule is that sending or forwarding political e-mails to anyone over a government system is political activity and thus prohibited.
